**LEGAL TIP**  
 Homeowners who allowed a group of high school students to hold a party on their premises despite knowing that there would be underage drinking could be sued when one of the partygoers caused an accident while driving home, the Wisconsin Court of Appeals has ruled in reversing a dismissal.  
 The homeowners allowed the party to take place on their property knowing that underage party guests were consuming alcohol. They did not provide or supply the alcohol, but they did not supervise or prevent its consumption on their property.  
 An intoxicated underage guest drove home from the party and collided with another vehicle, injuring the people inside. The victims sued the driver as well as the homeowners, alleging common law negligence.  
 The court said the suit could go forward.
